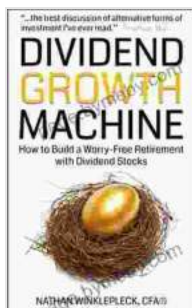

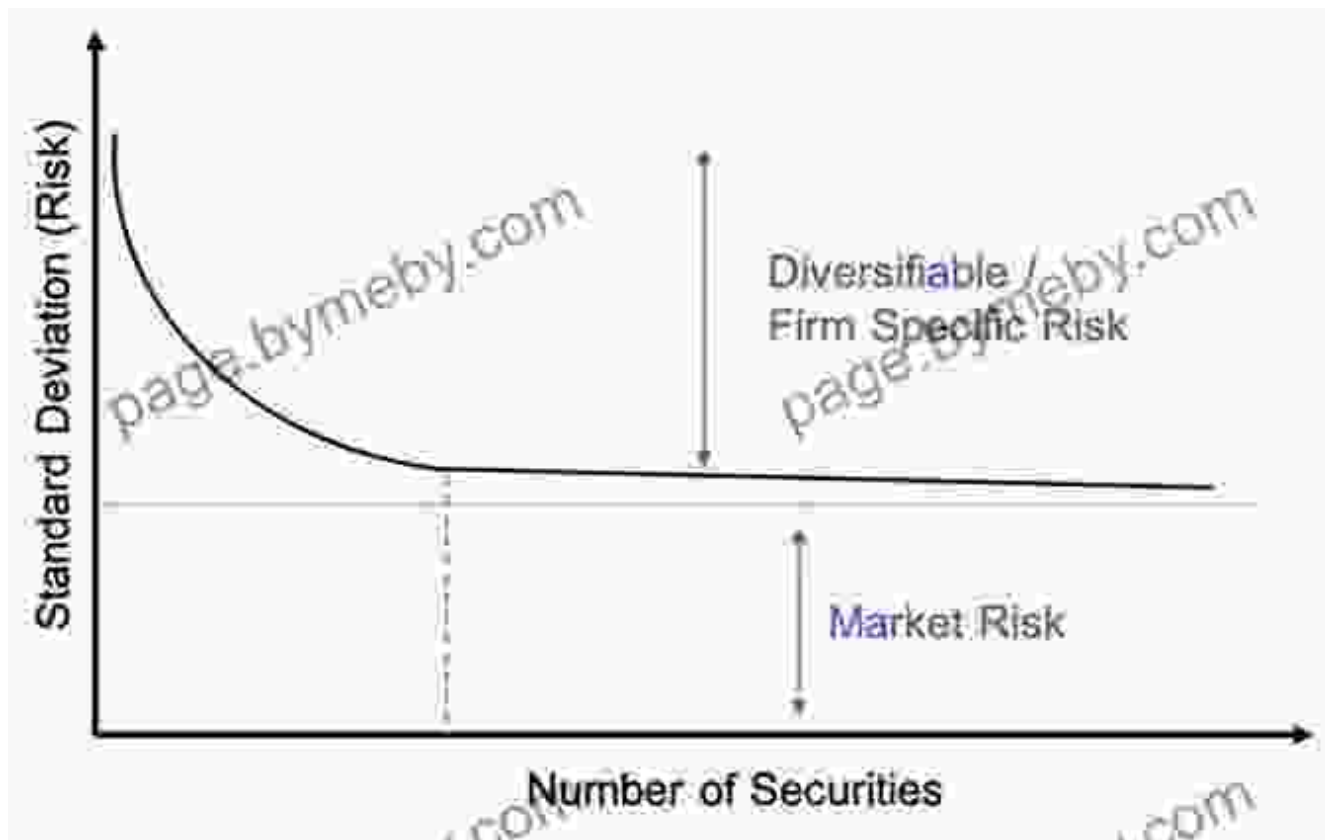

Advance tax provisions apply if the total tax liability of the taxpayer is equal to or more than Rs.10,000 in a particular financial year

Category of Assessee	Dividend Nature	Tax Rate
Resident	Dividend received from domestic company	Normal rate of tax applicable to the assessee
NRI	Dividend on GDR of Indian Co./PSU	10%
NRI	Dividend on share of Indian Co. (Purchased in foreign currency)	20%
NRI	Any other dividend income	20%
FPI	Dividend on securities other than 115AB	20%
Investment division of offshore banking unit	Dividend on securities other than 115AB	10%

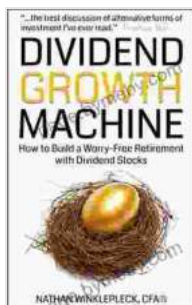

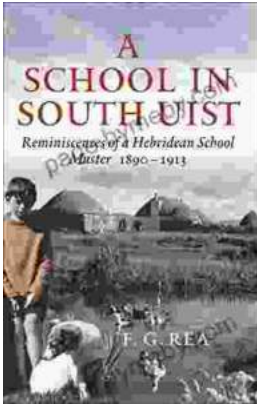
